Bidders, submitting their bid electronically, should deposit the cost of bidding document (amount mentioned in above table) in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2019-05-02 at Siddha Kumakh Rural Municipality, Office of Rural Municipal Executive, Dhorchaur, Salyan. Bids must be valid for a period of 90(Ninety) days after bid opening and must be accompanied by a bid security (amount mentioned in above table) or scanned copy of the bid security in .pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
