A complete set of Bidding Documents may be purchased from Siddhakumakh Rural Municipality Office, Dhorchaur, Salyan by eligible Bidders (Fabricators) on the submission of a written application, along with the copy of company/firm registration certificate, VAT Registration Certificate, Fabrication Authorization evidence from DoLI and upon payment of a non-refundable fee of NRs. 1000.00 till 2077-10-25, during office hours.
- 4. Sealed bids must be submitted to **Siddhakumakh Rural Municipality Office** by hand on or before **12:00 Noon** on **2077-10-26**. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2077-10-26, 14:00 hour at Siddhakumakh Rural Municipality Office, Dhorchaur, Salyan. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs. 35,000.00, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Account No.: Ga-3-08603000180, Dharauti Khata, Siddha Kumakh Ga.Pa. at Laxmi Bank Limited, Dhorchaur, Salyan and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
