

The Siddhakumakh Rural Municipality, Dhorchaur, Salyan invites sealed quotations from registered Suppliers for the supply, delivery, installation and testing of **Desktop Computer-5 Nos., Printer-5 Nos, Scanner-5 Nos and 4G wireless dongle -5 Nos** under IFB no. : **SKRM/SQ/GOODS/077/78-03**. Total Estimate Amount for the supply of goods is **4,64,000.00** Exclusive of VAT.

A complete set of Bidding Documents may be purchased from the office of Siddhakumakh Rural Municipality by eligible Bidders/Suppliers on the submission of a written application, along with the copy of company/firm registration certificate, tax clearance certificate of FY 2076/77 and upon payment of a non-refundable fee of NRs. **1000.00** till **2077-11-14** during office hours.
4. Sealed bids must be submitted to the office Siddhakumakh Rural Municipality Dhorchaur, Salyan by hand on or before **12:00 noon** on **2077-11-16**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2077-11-16, 14:00 hour** at the office of Siddhakumakh Rural Municipality, Dhorchaur, Salyan. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs. **14,000** which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No: **Ga-3-08603000180, Dharauti Khata, Siddha Kumakh Ga.Pa. at Laxmi Bank Limited, Dhorchaur, Salyan**] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
